Voting Information

Información Sobre la Votación

Voter Registration

Citizens who want to vote must be registered at their current address at least 30 days prior to Election Day.

Registro de Electores

Al menos 30 días antes del día de las elecciones, los ciudadanos que quieran votar deben estar registrados en su dirección actual.

Requisitos

- Citizen of the United States
- Resident of the County
- 18 years of age on Election Day
- Must not have been declared mentally incompetent by a court with right to vote removed
- Must not have been convicted of a felony, or, if convicted, have received a certificate of discharge or pardon

Calificaciones

- Ser ciudadano de los Estados Unidos
- Ser residente del condado
- Tener 18 años de edad el día de las elecciones
- No haber sido declarado mentalmente incompetente por una corte quitándole el derecho al voto
- No haber sido condenado de un delito grave, o, si fue condenado, debe haber recibido un certificado de liberación de los cargos o un indulto

Voter Registration is Permanent

At the start of every even-numbered year a new voter registration certificate will be mailed to each registered voter. Voters who have moved or have not received a current certificate are urged to confirm or update their registration by contacting the Tax Office at 713-368-8683 in a timely manner.

Note: College students may register and vote using either their family home address or their residence address at school.

El Registro de Elector es Permanente

Voting Information

On Election Day each voter *must vote in the precinct of record*. Photo ID or a current voter registration certificate is required. Precinct lists giving polling locations are printed in the newspapers immediately before an election and can be obtained by calling 713-368-8683 or checking online at www.harrisvotes.com.

Early Voting in Person

Early voting begins on the 17th day before the election and ends on the 4th day before the election. All registered Harris County voters may vote early at any Harris County early voting location in person.

Votación Adelantada en Persona

Votación adelantada comienza 17 días antes de las elecciones y termina 4 días antes de las elecciones. Todos los electores registrados en Harris County pueden votar temprano en persona en cualquier lugar de votación temprana.

Voting by Mail

Those voters 65 years of age or older and those who are sick or disabled may vote by mail. Qualified voters who will be absent from the county both on Election Day *and* during early voting may vote by mail. Voters may request an application to vote by mail from the County Clerk's office as early as 60 days prior to Election Day; Applications must be received no later than 7 days prior to Election Day. Votando por Correo
